EBB Annual General Assembly elects leadership for the next two years

On 13 October 2022, during the 2022 EBB General Assembly, EBB members elected the new EBB Executive Board for the term 2022-2024. Mr. Dickon Posnett, from the company Argent Energy, was elected as EBB President, together with the 2 Vice-Presidents and 8 Board members.

Mr. Dickon Posnett is the Director of Corporate Affairs for Argent Energy (with footprint in The Netherlands and UK), where he helps to develop markets for renewable fuels through regulatory and legislative incentives across the EU. He has been involved in the EBB for several years, both as a member of the EBB Executive Board, and as chair of the EBB Advanced Biodiesel Working Group.
